## 2026 SCHOOL FEE INFORMATION FOR FAMILIES

*School fees/levies are essential for the financial viability of Catholic schools. The school has many financial commitments that rely on the fee income we receive from our families.*

### PAYMENT OF SCHOOL FEES BY INSTALMENT

School Fees are invoiced as an annual account, due for payment in full 30 days after invoicing. Many families elect to pay their school fees by regular instalments. If you wish to take up this option, please complete a Request to Pay by Instalment Form which is available on the school's website or from the school's finance office wall holder. On completion of the request either email it to [instalments@dow.catholic.edu.au](mailto:instalments@dow.catholic.edu.au) or submit it at the school office. Following receipt of the request, instalments will be generated on your school fee account during the process of invoicing 2026 school fees. Your school fee statements will be emailed to you and they will provide a list of scheduled payments and their due date depending on the frequency you have chosen e.g. Fortnightly, Monthly, etc.

**IMPORTANT:** Please note that if you currently have a child or children at another school in the Diocese and you are paying by instalments at this location, you will not need to complete another Request to Pay by Instalment. The instalment request carries over from school to school with the same frequency of payment e.g. Weekly, fortnightly, etc. Please note it is only necessary to complete this form ONCE during the period of child/children's enrolment unless you wish to amend your payment frequency. Completion of a Request to pay by instalment IS NOT an authority for payment from your bank account, you need to set up BPay or a regular payment from your bank.

### PAYMENT OF SCHOOL FEES BY AGREEMENTS

Many families wish for a more flexible payment arrangement paying irregular lump sums throughout the year ensuring fees are paid in full by year end or an annual payment at tax time or after the 30 days deadline in February have lapsed. ### SCHOOL FEE ACCOUNT ENQUIRIES

The invoicing of school fees and the distribution of school fee statements each month, is carried out by the Catholic Education Office. Payment of fees, whether as an annual payment or payment by instalments is due on the date/s provided on your school fee statement. St Joseph's will always be your point of contact for matters pertaining to fees. If you wish to discuss your school fee account, please contact St Joseph's finance office.

Description	Explanation
Resource Fee & Technology Fee	This fee contributes to the shared student and teacher resources required daily. For example, library books and technology software and apps. Usage of the network, maintenance & upgrades IT Infrastructure
Sport Fee	This covers school sport activities, external coaches/instructors including transport
Tuition Fees	This fee funds the teacher salaries not covered by government funding, as well as the daily operational costs of the school. For example, electricity, water and insurance.
Building Fund Levy	This fee pays for our loans on the school's building and is equivalent to a mortgage payment. The Levy is charged per child with sibling discounts available. This is no longer tax deductible
Parents & Friends Levy	This levy replaces the need for major fundraising activities for parents and carers.
School Yearbook	Each family is provided with a copy of the Yearbook which becomes a valuable memento of school life.
EVET and other provider courses	EVET courses will be 25% of the course cost as determined by the provider. These fees will be billed separately to all the other school-based fees.
Course Fees	Many courses are required by the syllabus to include practical experiences. Fees cover the cost of consumables in these courses
First Aid Course	First Aid Course: It is compulsory for all Year 10 students to participate in the first aid course.
Excursions	Camps & Excursions are compulsory. Exemption for attendance must be sought in writing through the Principal. If applicable a medical certificate must accompany the request.
